



PARTICIPANT WAIVER AND RELEASE OF LIABILITY AGREEMENT

I, for and on behalf of the below-named Participant, acknowledge that the Michigan Jaguars FC is assisting in various recreational and soccer activities (the “MJFC Activities”) on a volunteer basis at the New Hope Kid’s Grief Camp (the “Camp”) operated and sponsored by the New Hope Centers for Grief Support, Inc. (“New Hope”). I understand that participation in the MFC Activities at the Camp carries with it the potential risks for serious personal injury, up to and including death. The risks include, but are not limited to, those caused by the terrain, facilities, temperature, weather (including lightning), equipment, vehicular traffic, and actions of other people, including but not limited to other participants, coaches, officials, volunteers and spectators. I represent that the Participant is in good health and good physical condition and that the Participant has not been advised otherwise by any qualified medical personnel. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me or the Participant, or any loss or damage of property owned by me or the Participant, as a result of being involved or participating in the MJFC Activities at the Camp, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.

In consideration for my participation in the MJFC Activities, I hereby for myself and on behalf of the Participant and our respective executors, administrators, heirs, next of kin, successor and assigns, agree to: (1) WAIVE, RELEASE, DISCHARGE the Michigan Jaguars FC Holding Inc., its affiliates, subsidiaries, owners, officers, employees, volunteers, coaches, representatives, assigns and/or others working on behalf of the Michigan Jaguars FC Holding Inc. (collectively the “Releasees”) from any and all liability, claims, costs, expenses, attorney fees, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, personal injury, including death, disability, property damage, property theft or actions of any kind, including during my travel to and from, or participation in MJFC Activities at the Camp; and (2) to the fullest extent permitted by law, INDEMNIFY AND HOLD HARMLESS the Releasees from any and all liabilities or claims made by other individuals or entities as a result of or relating to the Participant’s participation in the MJFC Activities at the Camp.

I, on behalf of myself and the Participant, acknowledge that this Participant Waiver and Release of Liability Agreement shall be construed in accordance with the laws of the State of Michigan. I acknowledge and represent that I have read this Participant Waiver and Release of Liability Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am fully competent; and I execute this Participant Waiver and Release of Liability Agreement for full, adequate and complete consideration fully intending to be bound by same.
